REAL ESTATE SIGNAGE REGULATION

The Board takes this opportunity to remind all Members of the real estate sign policy for Bear Brand at Laguna Niguel Community Association and all Bear Brand communities, including the Ridge.

A prototype sign has been prepared for Bear Brand Ridge and is available for purchase at Contact R.E.S.S., 23252 Del Lago, Laguna Hills, CA; 949-855-1355. Unapproved signage will be removed by the Patrol Company and placed in the Guard Shack for 30 days. If not claimed within 30 days, they will be discarded.

PET WASTE



Besides being a nuisance, uncollected dog waste is a serious problem for the association. Next time you're tempted to leave your dog's waste in the common area, please remember these facts:

1. The Environmental Protection Agency is becoming aggressive about enforcing the Clean Water Act. The association could be fined if dog waste goes uncollected.
2. *Uncollected dog waste may lead to a special assessment.* If fined by the EPA, the association could face a potential special assessment that would be levied against all members - not just dog owners.
3. *The appearance and quality of the common areas are known to affect home sales—*not just whether and for how much they sell, but how quickly.
4. The more residents complain about dog waste, the more time the manager must spend on enforcement rather than serving the association.
5. Uncollected dog waste spreads disease and attracts rodents who feed on pet waste.

With the increase in security cameras being installed, pet owners who do not pick up their pet's waste might be caught on CAMERA ~ which is considered verifiable confirmation of the offense and is subject to enforcement in accordance with the Violation and Fine Policy.
